At the regular meeting of the County Commission of Harrison County held on Wednesday, October 3, 2018. Commissioners Ron Watson, Bernie Fazzini and David Hinkle were present. Also present were Susan Thomas, County Clerk, and Willie Parker, County Administrator. Commissioner Watson opened the meeting and led those present in the Pledge of Allegiance to the Flag.

10:00 a.m. Proclamation – Breast Cancer Awareness – President Watson read a proclamation declaring Wednesday, October 3, 2018 as WV Breast Cancer Awareness Day and the entire month of October as Breast Cancer Awareness month.

10:05 a.m. Bill Hoover, General Manager – Greater Harrison Public Service District – Bill Hoover gave an update on water projects that have been completed to date and he spoke of priorities for projects that they are looking to complete in the future. Kylie explained cost involved to fund potential future projects. Mr. Hoover gave an update on sewer upgrades to be done in Phase II. Phase II is scheduled for a public service commission hearing before the Supreme Court on October 10th at 10:00 am. There are two cases pending before the Supreme Court. One is an appeal in regards to the public service commission ruling and the other one is in regards to an appeal of the Circuit Court ruling.

10:15 a.m. Estate of Jerryl A. Chandler, Jr – Petition to Remove Administrator – Steve Wickland and Judy Shanholtz, attorneys for both sides, were present. Mr. Wickland stated that they are willing to let Mr. Farley, Fiduciary Commissioner for the Estate, take a look at some of the issues in regards to the full accounting for the estate. Mr. Wickland would like to give the Administrator, Derrick Chandler, two weeks to submit his accounting to Mr. Farley. Judy Shanholtz stated that they will object to the appointment of Jimmie Mazzie as administrator if Mr. Chandler is removed as administrator at a later date. Fazzini made a motion to table the petition. Motion carried.

10:30 a.m. Tom Lee –Proposed Judicial Annex – Mr. Lee expressed his concern about “trashing our three courtrooms.” Fazzini made a motion to kill the project on the Second Street site and look for something else. Motion carried.

10:45 a.m. Property Maintenance Hearings –

Donna Jean Stickel – Summit Park – Donna Stickel and her sister-in-law Shirley Cochran were present. Danny Hamrick explained the history on the property. Donna Stickel presented more current photos that were taken Sunday, September 30th, that reflect the property has been cleaned up. Danny Hamrick will revisit the location and will give his recommendation to dismiss or reschedule another hearing at a later date.

Margaret Kirby Holmes – Kirby Hill – Diana Pyles and Amy Cunningham were present. Diana Pyles stated that no animals are on the property now. Diana Pyles stated she is buying the property. Pictures from October 1st show that the owners are working on cleaning up the property. Fazzini asked if they could have the property cleaned up by December 1st. They felt they could meet that deadline. Fazzini made a motion to give them 60 days. Hinkle suggested that only 30 days be given. Fazzini amended his motion to give them 30 days and for Danny Hamrick to check on the property. If no progress is made, then a hearing will be scheduled. Motion carried.


