If you are a Uniformed Service member, a U.S. citizen residing outside of the country, their spouse or dependent, or a person qualified for authorized late voter registration, you may use this form to request an absentee ballot. \* Applications may be received no earlier than January 1 and no later than 6 days before an election, and will remain active for the calendar year \*

**LATE REGISTRATION AND BALLOT REQUEST FOR RETURNING MILITARY:**

I understand that I must vote in person if I can (unless I am registering late). I understand that making a false statement on this application is a crime punishable by a fine up to \$1000 and up to one year imprisonment.
